# HOW COVID-19 HAS AFFECTED CHILDREN'S DENTAL CARE

According to the C.S. Mott Children's Hospital National Poll on Children's Health at Michigan Medicine 1 in 3 parents feels the pandemic has made it harder to get preventive dental care for their children. Findings also highlight how the pandemic may have disrupted access to dental care and increased disparities among low-income families.

As we approach more than a year of living with the pandemic, it's clear that dentistry remains essential, and we are pleased and grateful that we have been able to continue our services despite the challenges.

In Sullivan County, one of the poorest counties in New York State, many families face challenges in accessing dental care. It is harder for families on Medicaid to get dental appointments versus those with private dental insurance. Additionally, some parents have found long wait times for appointments, or that dental offices have closed or reduced their number of patients.

The COVID-19 pandemic has directly impacted the cost of running PRASAD's Children's Dental Health Program because of the drop in revenue from insurance reimbursements and the increased cost of dental supplies and Personal Protective Equipment. Despite this and given the pandemic, we are committed to providing the vital resource of dental care to children in need.
